

NatureBridge Health & Safety Plan (HSP)

Purpose

This document is intended to inform you of the current guidelines for NatureBridge programs regarding illness, including COVID-19. These guidelines follow CDC recommendations for community level transmission, California Department of Public Health (CDPH) and local National Park Service requirements. NatureBridge makes no guarantee that these guidelines will prevent a potential transmission of a communicable disease, including COVID-19. NatureBridge campuses may be operating at full capacity so you may expect to share space, both indoors and outdoors, with other schools onsite. These guidelines may evolve as new recommendations are issued from federal, state and county public health officials due to potential COVID-19 restrictions.

Participant Pre-Screen Questionnaire

School programs and/or Group Leaders are recommended to ask Participants the following pre-screen questions:

YES	NO	 2. Have you or any family members had close contact** with anyone diagnosed with COVID-19 or with signs/symptoms of illness in the last 10 days? Please contact NatureBridge if yo have had a close contact within 5 days of program start. *If anyone answers yes to questions 1 or 2, they must get a negative test 5 days after their exposure or symptoms began, submit their negative test result to school staff (who will attest to NatureBridge that they are negative) and be asymptomatic by the start of the program. *** Close contact is defined by the CDPH as someone sharing the same indoor space with an infected person for a total of 15 minute or more within a 24-hour period.
